**Please note**: The online system considers 11:59:00 pm ET (not 11:59:59 pm ET) to be the submission deadline and will not accept submissions after that point. Be sure to submit your application on time, as we will not accept late applications that result from technical issues with the online portal.

We appreciate the time and effort that applicants put into the Foundation's application process, and understand that it might be more intensive than applications to other philanthropic organizations. Our goal is to help develop and support strong proposals that are positioned to have the greatest impact in real-world, practical settings. - <u>Dissemination</u>. Describe plans for dissemination, including the peer-reviewed bioethics publications expected from the project and other means of dissemination beyond academic publication (e.g., to stakeholder audiences and to key individuals who can change practice or policy).
- <u>Innovation and impact</u>. Explain how the proposed project is innovative and builds upon current scholarship, and its potential impact on policy or practice.
- <u>Foundation's vision and mission</u>. Explain how the project will promote the Foundation's vision of *making bioethics integral to decisions in health care, policy, and research* and its mission of *expanding bioethics knowledge to improve clinical, biomedical, and public health decision-making, policy, and practice.*
- Research team. Provide a summary of the team's experience and expertise, including the team's expertise in relevant disciplines and methodologies, and their close familiarity and real-world experience with the bioethics problem(s) to be addressed.

Please be sure to include all of these sections in your narrative; failure to do so may render your application incomplete.
